## IV. Schedule.

Babysitting availability will be released to clients after the postpartum doula appointments are fulfilled. Babysitter and clients will work together to establish an appropriate schedule ahead of the service. Clients need to notify the babysitter at least 24 hours prior to beginning service when the pre-determined schedule needs to be canceled or rescheduled. New appointments also need to be made at least 72 hours prior to beginning service. Minimum hour of each service is 2 hours.

If the babysitter is unable to provide any services for unpredictable scheduling conflicts, there will be no charge for the missed services, or babysitter will refund the fees for the missed services. Every effort will be made to reschedule services at another time in the event of illness, serve weather, or other emergencies. Prior to signing this agreement, the babysitter shall disclose any potential scheduling difficulties she anticipates which may interfere with services.

**V. Responsibilities.** The Parties agree that the Babysitter shall have the responsibility of the general supervision and care of the Child(ren). In addition, the Babysitter shall be required to behave in accordance with the following rules and responsibilities:

- Babysitter provides supervision and care for child(ren) at their house or/and outside places (ex: park, library, mall) where parents are approved with consent. Babysitter communicate with parents to provide best care for their child(ren)
- Babysitter can do light housework in order to provide care for child(ren) such as preparing meals for child(ren), daily cleaning and laundry. Babysitter is not responsible for helping in heavy housework such as mowing lawn, shoveling snow, and heavy cleaning.
- Babysitter is not in charge of deciding any parenting choices.

## VIII. Termination of Service

Following situation will result in termination of contract by babysitter, and clients being charged fees in full:

- Safety of any Child(ren) and/or babysitter to be compromised;
- Dishonesty and/or Theft;
- Unapproved guests and/or housework which disturb babysitter's job as caregiver;
- Any illegal behavior or consumption of illegal substance
- Personal misrepresentation (not intending to fully utilize the services)
- failing to maintain communication with babysitter
- failing to compensate babysitter (pay your fee); and
- The breach of any statute or clause in this Agreement:

Failure to pay doula will result in legal action.

## IX. Additional Terms and Conditions.

- Up to 2 Children under age of 2 can be supervised and cared by a babysitter according to Alberta Child Care Regulation
- Car Seats for child(ren) are provided by parents
- Any expenses paid for child(ren) by babysitter during care will be charged with invoice to parents later (ex. Bus ride fee for commuting to daycare/school/lessons, Entrance fee to zoo, museums and other events, Safety equipment fee during boat ride etc.)
- Babysitter is not able to give care when child(ren) are sick
- Babysitting is supervising and caring child(ren) only. Parents can hire Sayaka Iwai as a postpartum doula If they need support and education of postpartum related topics.
- X. Entire Agreement. This Agreement, along with any attachments or addendums, represents the entire agreement between the Parties. Therefore, this Agreement supersedes any prior agreements, promises, conditions, or understandings between the Parties.
